BEING A BY-LAW OF THE RURAL MUNICIPALITY OF GIMLI TO AMEND BY LAW 14-0011 BEING A BY-LAW TO ESTABLISH SEWER AND WATER RATES FOR THE YEARS 2016, 2017 AND 2018 WITHIN THE RURAL MUNICIPALITY OF GIMLI;

WHEREAS Council of the R.M. of Gimli has been advised that the Rural Municipality of Gimli By-Law # 14-0011 is deemed to be in need of revision:

NOW THEREFORE BE IT RESOLVED that the following revisions be made to By-Law # 14-0011 Schedule "A", by replacing the following clauses:

1) Remove:

12.0 COMMERCIAL SEASONAL CUSTOMERS

That all commercial customers that have their water service disconnected in the fall and reconnected in the spring and that have a service size larger than the minimum size of 5/8" will pay the minimum metered amount, according to service size per quarter, while the water service is disconnected.

Replace and insert:

12.0 COMMERCIAL SEASONAL CUSTOMERS

Commercial customers may declare a property seasonal use whereby their building that is connected to municipal sewer and/or water will not be in use from January 1 to March 31 of each year and their utility bill will be discontinued for that quarter. Billing will automatically start on April 1 of each year. Once the commercial customer makes the declaration and if the building uses the utility service for any part of the quarter, the whole quarter will be charged regardless of the number of days use in the quarter.

2) Remove:

14.0 RESIDENTIAL CUSTOMERS CONNECTED TO THE NORTH FORCEMAIN Residents connected to the North Forcemain and have a low pressure sewer system will be entitled to be reimbursed for one pump out per year by the municipality.

Replace and insert:

$\underline{14.0~RESIDENTIAL~CUSTOMERS~CONNECTED~TO~A~LOW~PRESSURE~SEWER}$ SYSTEM

Residential or Commercial connections to a Low Pressure Sewer System will be entitled to be reimbursed for one septage pump out per year, per roll number.
