RURAL MUNICIPALITY OF GIMLI

BY-LAW NO. 19-0005

Being a By-law of the Rural Municipality of Gimli to establish regulations for the Gimli Public Beach.

WHEREAS Section 232 (1) of *The Municipal Act* provides that a council may pass bylaws for municipal purposes respecting the following matters:

- (a) the safety, health, protection and well-being of people, and the safety and protection of property;
- (b) people, activities and things in, on or near a public place or a place open to the public, including parks, municipal roads, recreation centres, restaurants, facilities, retail stores, malls, and private clubs and facilities that are exempt from municipal taxation.

NOW THEREFORE the Council of the Rural Municipality of Gimli enacts as follows:

1. **DEFINITIONS**:

"Gimli Public Beach" or "Gimli Beach" consists of the area between the main dock and Barney Thomas Drive and between Lake Winnipeg and the east boundary of the parking lot, which includes the sand, boardwalk and grass areas.

"Boardwalk" means both the wooden and paved pathway that runs adjacent to sand area on Gimli Public Beach.

- 2. **THAT** the following activities are not allowed on Gimli Beach in the Municipality:
 - a) Dogs and Domestic Animals are Not allowed on sand areas, but are permitted to walk along the Boardwalk on a leash no longer than 6 feet fully extended and must be cleaned up after and kept under complete control by a person capable to do so
 - b) Fishing from the shoreline on Gimli Beach
 - c) Feeding of shore birds
 - d) Camping or tenting at any time.
 - e) Motorized vehicles, excluding motorized mobility aids
 - f) Alcohol with the exception of periodic MLCC Licensed Events
 - g) Littering
 - h) Loud music with the exception of periodic Approved Events
 - i) Loud offensive language nuisance noise
 - k) Open fires of any type
 - 1) BBQ's and cooking are not allowed except on grass areas
 - m) Boats or motorized water craft inside identified swimming areas
 - n) Fireworks with the exception of periodic Approved Events

- 3. **THAT** the Municipality make an exception to motorized vehicles on the beach, for beach and boardwalk maintenance, and use of winter road access.
- 4. **THAT** the Municipality may arrange seasonal lease agreements with individuals or corporations wishing to operate, business on or adjacent to the Gimli Beach Area.
- 5. **THAT** the Municipality may only provide approval for events, temporary structures, concerts etc. upon the applicant obtaining a permit from Crown Lands or providing the municipality with confirmation from Crown Lands that no permit would be required.
- 6. **THAT** any person who violates, contravenes, or disobeys or refuses, omits, neglects, or fails to observe, obey or comply with any provision of this By-law is guilty of an offense and is liable, under the Provincial Offences Act, to a fine of not less than \$50.00 or more than \$1,000.00
- 7. **THAT** By-Law No. 13-0012 is hereby repealed.
