

RURAL MUNICIPALITY OF GIMLI

BY-LAW NO. 04-0018

BEING a By-Law of the Rural Municipality of Gimli, to fix the rate of indemnity for Council members, and the rate of remuneration for various services required to be rendered by members in addition to meetings of Council.

The Reeve and Council for the Rural Municipality of Gimli, in Council assembled, enact as follows:

1. **THAT** the rate of Indemnity for Council members for attending meetings, whether regular or special, shall be and is hereby fixed as follows:
2. Indemnity for the meetings for the Reeve at the rate of \$1,275.00 per month, 1/3 of which shall be paid as a non-accountable expense allowance exempt from income tax, Indemnity for meeting at the rate of \$925.00 per month for the Deputy Reeve, 1/3 of which shall be paid as a non-accountable expense allowance exempt from income tax, \$875.00 per month for Councillors; 1/3 of which shall be paid as a non-accountable expense allowance exempt from income tax, and, in addition, the Reeve and Councillors shall be entitled to receive a mileage allowance of \$0.38 for each kilometer actually traveled from their respective homes and return, attending meetings of Council whether regular or special.
3. **THAT** the remuneration of services rendered as: Road Commissioners, supervision of any works pertaining to Public Works, or of the maintenance thereof, and for attending meetings of committees or boards, for which the member of Council has not received any remuneration, and which is deemed by Council to be of a benefit and in the best interests of the Municipality, be and the same is hereby fixed at the rate of \$15.00 per hour required for this work, 1/3 of which shall be paid as a non-accountable expense allowance exempt from income tax, and, in addition, the sum of \$0.38 per kilometer actually traveled in the performance of any of the foregoing work required.
4. **THAT** the rate of remuneration for all members of council directed to attend to special business of Council, other than as members of a committee in the work of attending meetings of that committee, and at which attending of the special business is required outside of the Corporation, and also attending of Municipal Conventions outside of the Municipality, shall be and the same is hereby fixed at the rate of \$150.00 per day, 1/3 of which shall be paid as a non-accountable expense allowance exempt from income tax, and in addition, the usual fare required to and from destination and, in addition, a meal allowance of \$40.00 per diem, and, in addition, the actual living expenses for each day

while away from the municipality attending the function on behalf of the Municipality to which a Resolution of Council so directs.

5. **THAT** each member of Council shall be entitled to an advance payment of an amount up to the difference in the cost of business and all purpose vehicle insurance for the personal use vehicle of the member of Council, such amount shall be recovered from subsequent mileage expense payments to the member of Council.
