RURAL MUNICIPALITY OF GIMLI BY-LAW NO. 25 0007

BEING A BY-LAW OF THE RURAL MUNICIPALITY OF GIMLI to revise and update the fees and charges payable to the Municipality for services rendered and facilities provided under the authority of The Municipal Act, The Planning Act, The Noxious Weeds Act, and the By-laws of the Municipality;

WHEREAS the Council of the Rural Municipality of Gimli deems it advisable to include in one by-law such fees and charges;

NOW THEREFORE the Mayor and Council of the Rural Municipality of Gimli in open session assembled, enacts as follows:

- 1. This By-law shall be known as The Fees and Charges By-law.
- 2. The fees and charges for services rendered and facilities provided shall be as set out in the following attached schedules:

Schedule A	Public Safety Department
Schedule B	Public Works & Operations Department
Schedule C	Economic and Community Development
Schedule D	Finance and Administration
Schedule E	Gimli Airport Fees
Schedule F	Recreation Department Fees

- 3. The fees and charges set out in the schedules take precedence over those in previous by-laws, except where a by-law is referred to in a schedule.
- 4. Council may from time to time, by resolution, amend the schedules.
- 5. Unpaid fees or charges plus applicable penalties may be collected or enforced in the same manner as a tax may be collected under The Municipal Act.
- 6. Except where required by law or to respond to an emergency, the Municipality may discontinue or refuse to provide a service or facility to a person who is in default of payment of a fee or charge.
- 7. By-law 19-0015 is repealed.
